



DR Market Notification Update – Russia

TO ALL HOLDERS AND BENEFICIAL OWNERS FROM TIME TO TIME OF AMERICAN AND GLOBAL DEPOSITARY SHARES (“DRs”) ISSUED AND OUTSTANDING IN DR PROGRAMS FOR THE RUSSIAN ISSUERS IDENTIFIED BELOW (THE “RUSSIAN DR PROGRAMS”).

Citibank, N.A. and Citigroup Global Markets Europe (with respect to PJSC PhosAgro), as Depositary (collectively, the “Depositary”) refer to the Depositary’s updated notice to DR holders of Russian DR Programs dated August 5, 2024, regarding the closing of books for DR cancellations (the “[Prior Notice](#)”)

The Depositary has been advised that as a result of Russian Presidential Decree 840 dated October 2, 2024 (the “Decree”), pertaining to the safekeeping of certain securities in the Russian market, share delivery instructions not settled prior to that date have been canceled. In effect, the Decree precluded share settlement in Russia’s National Securities Depository of share deliveries related to DR cancellation requests not settled by October 2, 2024, the Decree issuance date. As a result, **DRs presented for cancellation by the October 1 deadline set by the Depositary as detailed in the Prior Notice that are connected to share deliveries not settled as a result of the Decree will be returned.**

To the extent a broker or intermediary presented such DRs, the Depositary will attempt to return such DRs through that broker or intermediary. In some cases, if a DR return cannot be made through the broker or intermediary that presented the DRs for cancellation, the Depositary may, where possible, register the DR owner directly on the applicable DR share register.

Capitalized terms used herein but not defined shall have the meanings assigned to such terms in the Prior Notice.
