Votorantim Celulose e Papel S.A. appointed Citibank, N.A. as Successor Depository for their ADR program. The Effective Date was August 12, 2009.

In addition, August 12, 2009 was the record date in Brazil for the exchange of the Deposited Securities from Preferred Shares to Common Shares. Shareholders received 0.91 Common Shares for every one (1) Preferred Share held as of the record date.

As a result of the exchange in the local market, holders of existing ADSs will receive 0.91 New ADS (backed by common shares) for every one (1) existing ADS held (backed by preferred shares) as of the ADS effective date, August 18, 2009. No fractional New ADSs will be issued. Instead, Citibank, N.A., as the Depositary for the New ADSs, will aggregate all fractional entitlements to New ADSs and sell them in the open market and will remit the net cash proceeds (after deduction of applicable fees, taxes and charges) to the applicable holders.
