Enel Americas S.A. is offering to their common stockholders transferable rights to subscribe for 504,945,557 new shares of common stock in the Republic of Chile and outside Chile, including shares of common stock represented by American Depositary Shares, or ADSs. Each ADS holder that participated in the Preemptive Rights Offering will be entitled to participate in the secondary rights offering. One ADS right is required to subscribe for one new ADS at the subscription price of US\$ 8.31 per new ADS. The ADS Rights are transferable and should be admitted for trading on the New York Stock Exchange under the symbol "ENIA RT". The ADS rights CUSIP number is 29274F146 (DR ISIN US29274F1460).

Trading of the ADS Rights on the NYSE is expected to commence on or about August 7, 2019.



Rights Allocation/Eligible Holders:

Each holder will be entitled to receive 0.0277064418840738 transferrable rights for each new ADS subscribed in the preemptive rights offering. Fractional rights will be aggregated and sold. The mail date for ADS Rights will be August 6, 2019.

Exercise Terms:

Each ADS right plus \$ 8.31 entitles the holder to subscribe for one new ADS. The exercise of ADS rights is irrevocable.

ADS Subscription Price: The subscription price is \$ 8.31 per New ADS. The ADS subscription price is based on fifty (50) times the subscription price for new shares of the common stock of US\$0.162108214203236 per new share, plus a fee in connection with the ADS rights and the issuance of the new ADSs of US\$0.20 per new ADS subscribed.
