The Depositary was notified by the company, Enersis Américas S.A. (formerly Enersis S.A.) (the "Company"), that the Company is conducting a demerger involving the creation of Enersis Chile S.A. to hold the Chilean electricity generation businesses and assets of the Company, and the distribution by the Company to its shareholders of all outstanding shares of common stock of Enersis Chile S.A. at the rate of one share of Enersis Chile S.A. common stock for each share of the Company's common stock outstanding on the Record Date and one American Depositary Share ("ADS") of Enersis Chile S.A. for each ADS of the Company outstanding on the Record Date.

The local Record Date for such distribution will be April 20, 2016, and the distribution date in the local market will be on or about April 21, 2016. The Record Date in the U.S. for such distribution will be April 14, 2016, and the distribution date for the Enersis Chile ADSs will be TBD.

No action on the part of Holders or Beneficial Owners is required.

The distribution of Enersis Chile S.A. common stock and ADSs are subject to the satisfaction or waiver of certain conditions including, but not limited to, registration of the shares of Enersis Chile S.A. common stock with the Chilean Superintendence of Securities and Insurance and the receipt of approval to list the shares of common stock on the stock exchanges in Chile.

Concurrent with the commencement of "regular way" trading of the Enersis Chile S.A. ADSs on the NYSE under the ticker symbol "ENIC", the ticker symbol for the Enersis Américas S.A. ADSs is expected to change from "ENI" to "ENIA".
